Rate Increase:

Superintendent Gardner presented the proposed rate schedule to Trustees. We will file with the PUC tomorrow and will mail and post the public notice on June 5th. The public hearing will be held on June 20th. The effective date should be August 1st.

Water Tap for Water Transport Trucks:

Superintendent Gardner reported that the installation of the fill station is just about done. Trustees discussed rates and decided on \$65 per load (up to 8000 gallons).

Motion/Second by MacDonald/Murray to set the bulk water rate at \$65 per load. Vote to approve was unanimous.

N. Raymond Rd - New Water Main:

Superintendent Gardner reported that the probable cost for this project is \$500,000. We are working on securing the funds through Rural Development. The environmental permits will take three months. We will be going through a 10-day bid process. Our goal is for work to be underway in September as this project must be done before winter due to customers being served by temporary above ground water.

NEW BUSINESS:

Weeks Hill Antenna Agreement:

Trustee Murray initiated working on a new agreement with the Town now that the Dry mills agreement is completed. Our existing agreement for the Weeks hill tank is a MOU and it needs to be upgraded to a license agreement.
